

## THIS IS YOUR HUDSON FESTIVAL 2018 VENDOR CONFIRMATION LETTER!

The Hudson Fest is a few weeks away (June 9th) and we are eager to work with you! Please follow the general guidelines below. **The Fest will go on rain or shine. No refunds shall be given.** While some have requested **shade**, shade is scarce. We recommend that you bring a pop-up or umbrella.

**Upon Arrival, all vendors must register in the Amvet Parking Lot.** GPS Address: 5 South St., Hudson MA. During Set-up, South St. will be one-way (W to E). Volunteers (yellow vests), will help vendors locate their site. Most will park in the Houghton Street Lot, and trailers must be unhitched. Vendor Spaces are pre-assigned. Changes will **not** be made until after 9:30 am.

Set-up is from **6:45 to 8:25 am**. Coffee and muffins will be available to purchase at registration. Also, there are cafes within easy walking distance. **From 8:30 am to 3:30 pm**, South St. will be closed to all through traffic. **All vendors must be at their site, with their car removed by 8:25 am.** Unless there are issues of public safety, early breakdown is not allowed. Those that breakdown early will be purged from both the Hudson and Maynard Festival lists. Please be prepared to manage your site for the duration of the event.

Any vendor offering food/beverages must be permitted by the Board of Health. If you plan to offer any consumable, and did not indicate this on your application, let us know, ASAP.

At present, we have 4 vendor spaces left. After these are sold, we will create a waiting list.

You need to bring your own table and chairs (if you need to rent them, call Robinsons Rental at 978.562.7316). No vendor will be allowed to sell **any** type of toy weapon, silly string, stink bombs, snappers, or colored hair spray. Festival Management retains the right to remove products that pose a public safety issue and/or contributes to graffiti. In all cases, common sense shall prevail.

No electricity is available. **No smoking is allowed within the vendor areas.**

### **DIRECTIONS: GPS ADDRESS: 5 South St., Hudson, MA**

**From 495 Traveling N**—Take exit 25A. At the end of exit (also the end of 290) you will see a 99 Restaurant to your right and a Plaza in front of you. Take a left down Washington Street (also Rte. 85), go over the bridge at the bottom of the hill, and take a right onto South St. The Amvet Lot is about 100 yards on your right. .

**From 495 Traveling S**—Take the Rte. 62, Hudson/Berlin Exit. Take a right and follow signs toward Hudson. You are on Coolidge St., which merges into Central St. Central St. will bring you to the Hudson Rotary. Stay to the right of the Rotary and take your 1<sup>st</sup> right onto Washington Street. Take your 1<sup>st</sup> left onto South St. Travel 100 yards, and the Amvet Lot's on your right.

**From Points East** – Take Rte.62 West toward Hudson/Berlin. Follow the road through downtown Hudson, until you reach the Rotary. Take your 3<sup>rd</sup> right onto Washington Street; then take your 1<sup>st</sup> left onto South St. Travel 100 yards, and the Amvet Lot's on your right.
